Our firm, Arbor Trust Wealth Advisors, LLC, is registered as an investment adviser with the U.S. Securities and Exchange Commission. **Relationships and Services**

What investment services and advice can you provide me?
<p><b>Services:</b> We offer investment advisory services to retail investors. These services include investment management and financial planning. In addition to investment management, we may also provide trust administrative support and estate settlement support services in certain circumstances. We work closely with you to identify your investment goals and objectives, as well as risk tolerance and financial situation in order to create a portfolio strategy.</p>
<p><b>Accounts, Investments, and Monitoring:</b> We provide services to individual, joint, retirement, trust and estate accounts. We primarily construct portfolios consisting of individual equity securities, individual fixed income securities, mutual funds, and/or exchange-traded funds. In certain circumstances, we may also employ limited partnerships, real estate investment trusts and other types of investments, as appropriate. We do not make available or offer advice with respect to proprietary products or a limited menu of products or types of investments. As part of our services, we monitor portfolios and securities in accounts on a regular and continuous basis. We also meet with you at least annually, or more frequently, depending on your needs.</p>
<p><b>Investment Authority:</b> We provide our services on a perpetual and discretionary basis. We execute investment recommendations in accordance with your investment objectives without your prior approval of each specific transaction. Our engagement will continue until you notify us otherwise in writing.</p>
<p><b>Account Minimums &amp; Other Requirements:</b> We do not require an account or relationship size minimum in order for you to open/maintain an account or establish a relationship. However, Tri-Star Trust Bank generally requires a relationship minimum of \$300,000.</p>

**Fees, Costs, Conflicts, and Standard of Conduct**

What fees will I pay?
<p><b>Asset-Based Fees:</b> Our asset-based fee ranges from 0.60% up to 1.75% annually based on a tiered schedule and the scope of services. There is an additional 0.25% annual fee for trust administrative support. We generally require a minimum annual advisory fee of \$5,000 for investment management services. These fees are collected on a quarterly basis and calculated as a percentage of the value of the cash and investments in your account[s] that we manage. This presents a conflict of interest as we are financially incentivized to encourage you to place more assets in your advisory account as you will pay more in advisory fees.</p>
<p><b>Hourly Fees:</b> If applicable, our hourly fees for financial planning and consulting are at a rate ranging from \$200 to \$400 per hour. We collect fees in up to two separate installments. Hourly fees are negotiable based on the nature and complexity of the services to be provided and the overall relationship with us. We will provide you with an estimate for total hours and overall costs prior to engaging us for these services.</p>
<p><b>Fixed Fees:</b> If applicable, our fixed project-based fees for financial planning and consulting range from \$2,500 to \$5,000. We collect fees in up to two separate installments Fixed fees are negotiable based on the nature and complexity of the services to be provided and the overall relationship with us. We will provide you with an estimate of the total cost prior to engaging us for these services.</p>

**Other Fees & Costs:** In addition to our advisory fee, you will also be responsible for custody fees, account administrative fees, fees and expenses related to mutual funds and exchange traded funds, and applicable securities transaction fees. If you engage us for trust administrative support or estate settlement support services, you may pay additional advisory fees, including an additional asset-based fee and a minimum annual fee of \$10,000 for estate settlement services.

**Additional Information: You will pay fees and costs whether you make or lose money on your investments.** Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. **What are your legal obligations to me when acting as my investment adviser?  
How else does your firm make money and what conflicts of interest do you have?**

*When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means.*

We will recommend that you open your account with a specific custodian, where we maintain an institutional relationship and receive economic benefits. The receipt of economic benefits presents a conflict of interest and can influence our recommendation of the custodian to you. However, you ultimately decide where to open your accounts. Choosing a different custodian may result in the loss of quality of service and/or ability to obtain favorable prices.

**How do your financial professionals make money?**

Certain of our financial professionals are compensated based on an annual salary. Our other financial professionals are compensated based on the revenue generated from the accounts serviced by the firm. This means financial professionals have an incentive to increase the asset size in the relationship or solicit new business, taking time away from the day-to-day servicing of current clients.
